

## INDONESIA PROJECT 2007-2008: HIGHLIGHTS

Two core activities continued to be the major focus of the Indonesia Project in 2007-2008. The publication of the Bulletin of Indonesian Economic Studies, and various activities surrounding the holding of an annual Indonesia Update conference and publication of an edited volume based on the Update. Other activities include a regular seminar series, a visitors program, staff research and supervision of Phd students working on Indonesia, and a range of outreach activities. In addition, the Project initiated a number of new activities in 2007 and 2008 including a High Level Policy Dialogue (HLPD), in cooperation with the Ministry of Finance in Jakarta and Canberra, and a series of briefing papers for AusAID on subjects relevant to the Australian aid program in Indonesia.

Following an extensive review in 2007, a new grant contract was drawn up between the ANU and AusAID (the major external funding agency) to cover a new four year grant period from August 1, 2008 through to June 30, 2012. We are very grateful to AusAID for financial support that is integral to the Project's activities and to the ANU for core support for staff and facilities.

### **The Bulletin of Indonesian Economic Studies (BIES)**

The BIES remains the Project's flagship activity, and is edited by Ross McLeod assisted by Liz Drysdale as the Associate Editor. Three numbers were published each year during 2007-08 (see *Attachment A*). Each number includes the much cited survey of recent developments in the Indonesian economy written by Australian, Indonesian and international authors. A special issue in April 2008 was devoted to *Rice Policy in Indonesia* edited by Neil McCulloch and Peter Timmer, and coincided with a major crisis in international rice prices in the first half of 2008. Peter McCawley joined the Project as a Visiting Fellow in 2007 and assisted in editing this special edition during Ross McLeod's absence on study leave in the first half of 2008.

Articles on Indonesia in comparative East Asian perspective were commissioned in 2007 entitled *Asian Development Strategies: China and Indonesia Compared* (authors Bert Hofman, Min Zhao and Yoichiro Ishihara) and in 2008 entitled *Prospects for Skills-Based Export Growth in a Labour-Abundant, Resource-Rich Developing Economy* (authors Ian Coxhead and Muqun Li).

The paper on China and Indonesia was the subject of the on-going Mohammad Sadli Memorial Lecture series, and opened by the Minister of Trade, H.E. Dr. Mari Pangestu. The event was held in collaboration with the Faculty of Economics (Institute of Economic and Social Research, LPEM) at the University of Indonesia in Jakarta, on April 22, 2008. In the previous year, the inaugural Sadli Lecture was given by Professor Prema-chandra Athukorala from the Australian National University. Entitled *Is Indonesia Falling Behind? Post-crisis Export Performance in Regional Perspective*, the lecture was also held in collaboration with the University of Indonesia and given on April 24 2007 in Jakarta.

### **Indonesia Update Conference and Books**

The annual Indonesia Update conference held in Canberra is a major event on the calendar of the ANU and drew an audience of over 300 people in both 2007 and 2008. The 2007 Indonesia Update Conference entitled *Expressing Islam: Religious Life and Politics* was organised by Greg Fealy and Sally White and was held on September 7-8. In addition to presentations on political and economic developments, the conference brought together a range of noted scholars and public figures from Indonesia and Australia engaged in research on social dimensions of Islam. Professor Merle Ricklefs (National University of Singapore) was the keynote speaker.

In 2008, the Indonesia Update Conference examined Indonesia as an archipelagic nation and was entitled *Indonesia Beyond the Water's Edge: Managing an Archipelagic State*. Robert Cribb (ANU) convened the conference, which was held on 19-20 September (see *Attachment B* for details). The Update featured Howard Dick (University of Melbourne) as the keynote speaker. It focused on Indonesia's status as the world's largest archipelagic state, and how this status presents unique economic opportunities and political and strategic challenges associated with the special problems of governance. As in 2007, the conference also included presentations on recent political and economic developments.

'Mini Updates' based on each of the conferences are important events on the annual calendar of the Project. They were held on the Monday immediately following the Update in Sydney in 2007 and 2008, in collaboration with the Lowy Institute. These meetings featured several of the key speakers at the Update and a lively discussion of Indonesian affairs.

The Update book is published in collaboration with the Institute of Southeast Asian Studies in Singapore (see *Attachments C and D*). Book launchings were also held in Australia (Canberra and Melbourne) and in Indonesia (Jakarta). The Jakarta book launching offers an opportunity to present the main themes of the Update books to an Indonesian audience at a half day seminar held in collaboration with the Center of Strategic and International Studies (CSIS). The Project is extremely grateful to CSIS and especially its executive Director, Hadi Soesastro, for collaboration in this activity which regularly draws a lively audience of 100–150 researchers, students, policy makers and interested observers in Jakarta.

In this series, a seminar on the Update book *Indonesia: Democracy and the Promise of Good Governance*, edited by Ross McLeod and Andrew MacIntyre and based on the 2006 Update conference, was held on June 27, 2007. Andi Mallarangeng, spokesperson for the President of Indonesia, gave the keynote address. In the following year, the edited book based on the 2007 Update conference, *Expressing Islam: Religious Life and Politics* was officially launched by Mr Blair Exell, Minister-Counsellor at the Australian Embassy and director of AusAID's Indonesia program, on August 26, 2008.

### **Other Activities**

The other main activities of the Project in 2007 and 2008 involved a regular seminar series held at the ANU (the Indonesia Study Group), a visitors program, staff research and outreach activities and supervision of theses written by research students, most of them Indonesians on AusAID scholarships undertaking research for PhD degrees.

The *Indonesia Study Group* involves some 25–30 seminars each year on topical issues in Indonesian affairs, especially current politics and economics, and also covering the areas of culture, religious and social developments, and international relations (see *Attachment E*). Speakers are drawn from Indonesian visitors to ANU, scholars from other Australian universities, policy makers, and ANU students and academics. The seminars are attended by audiences of 20–50 persons from on and off campus.

The *Visitors Program* brings Indonesian researchers to Canberra for periods of one to four weeks to present seminars and write up on-going projects for publication, both on an individual basis and in collaboration with Project and other ANU staff (*Attachment F*).

*Outreach* involves briefings to Australian government agencies, especially AusAID, and contributions to newspapers and radio and television programs in both Australia and Indonesia. The *High Level Policy Dialogue* is one major outreach activity in collaboration with the Ministry of Finance in Jakarta. These meetings have been financially supported by AusAID at the request of the Indonesian government. They involve the participation of AusAID and the Australian Treasury, and several key economic institutions in Jakarta (Bank Indonesia, The Ministry of Trade, the Economics Coordinating Ministry and the Planning Agency, BAPPENAS). A select group of Australian academics and policy authorities attend the meetings. They involve presentations by both Australians and Indonesians, and discussions of pressing policy issues. Meetings were held in Canberra in June 2007 and October 2008, and a two day meeting was followed by a presentation of the results directly to the Minister of Finance in Jakarta on November 30, 2007. A further meeting is scheduled for February 2009 in Jakarta.

Six *students* supervised by Project staff in the Arndt-Corden Division of Economics completed PhDs on Indonesian economics in 2007–8 and a further seven were enrolled as of December 2008. Topics of the theses varied widely, including regional development, poverty, macroeconomics, environment and trade and investment (see *Attachment G*).

### **Organisation of Project Activities**

The project is managed by Chris Manning as Project Head assisted by Cathy Haberle as the Administrator. The Project is an integral part of the Arndt-Corden Division of Economics in the Research School of Pacific (RSPAS) and Asian Studies, College of Asia and the Pacific. Project Staff are drawn from the Division of Economics and also from the Department of Political and Social Change in RSPAS. Research Associates supporting Project activities are from other Faculties in the University, as well as from other institutions in Australia and Indonesia. *Attachments H* and *I* provide details on staffing and a list of research scholars attached to the Project.

Guidance on Project activities and initiatives is provided by an Advisory Board, mainly comprising ANU staff and several prominent researchers on Indonesia and Asia at other universities in Australia. The Board also includes policy makers and representatives of institutions outside the higher education sector, including AusAID,

the Australian Treasury, the Commonwealth Bank and World Vision. Three prominent Indonesians also play an active role on the Advisory Board, including the current Minister of Trade, Mari Pangestu, in the Yudhoyono government. The Advisory Board met twice annually in 2007 (April and October) and once in 2008 (October). A list of Board members is presented in *Attachment J*.

### **Staff Research**

Research undertaken by Project Staff is a vital part of the work of the Project, feeding into all major activities. Research focuses on economic, political and social aspects of Indonesian development (See *Attachment K* for a list of publications by staff attached to the Project). Research findings are published in international journals (including the BIES), books, monographs and working papers. In the field of economics, the focus of staff research has been on trade and investment, ASEAN and East Asian economic relationships, regional development, governance, the environment and climate change, economic history and labour issues. Other staff members have published papers on political developments, including on the resolution of the longstanding armed struggle in Aceh, political and ethnic conflict, and social and political dimensions of Islam in Indonesia.
