Peter Whiteford (FASSA) is a Professor in the Crawford School of Public Policy at The Australian National University, Canberra and an <u>Adjunct Professor</u> with the Social Policy Research Centre at the University of New South Wales. He is the Director of the <u>Social Policy Institute</u> and a Fellow of the <u>Tax and Transfer Policy Institute</u> in the Crawford School. From 2015 to 2017, he was Director of the <u>Policy and Governance</u> Teaching Programme in the Crawford School, administering the School's Master of Public Policy and Master of Public Administration. He is an Associate Investigator with the ARC Centre of Excellence in Population Ageing Research (CEPAR). He is a Fellow of the <u>Australian Basic Income Lab</u>.

He is an expert on international comparisons of social security policies, and on inequality and redistribution. He is the author of more than 100 articles in refereed journals, book chapters or monographs and he has been a keynote speaker or invited presenter at more than 35 international and Australian conferences. He has written extensively on social assistance in OECD countries and the design and effectiveness of income-tested benefit systems. He has also worked on pension issues in OECD countries, including on the public/private pension mix, pension reform in Eastern Europe, China, Australia and APEC economies, as well as on the living standards of pensioners in a comparative perspective.

Between 2000 and 2008, he worked as a Principal Administrator in the Directorate of Employment, Labour and Social Affairs of the Organisation for Economic Co-operation and Development in Paris. His work at the OECD encompassed pension and welfare policies in OECD countries, Eastern Europe and China. He also worked on child poverty, family assistance policies, welfare reform, and income inequality and redistribution. He has been a consultant for the World Bank, the Asian Development Bank, UNICEF and the OECD. He has been an expert referee for the Australian Parliamentary Budget Office, the Productivity Commission and the Australian Institute for Health and Welfare, as well as for numerous academic journal articles.

He has worked at the <u>Social Policy Research Unit</u> at the University of York in the United Kingdom, as well as a Consultant to the <u>Social Security Review</u> in Canberra and the <u>New Zealand Royal Commission on Social Policy</u>. He worked at the Social Policy Research Centre (SPRC) at the University of New South Wales (UNSW) between 1986 and 1990 and in 1995, as well as between 2008 and 2012. In July 2008, he was appointed by the Australian government to the Reference Group for the Harmer <u>Review of the Australian pension system</u>. He was an invited keynote speaker at the <u>Melbourne Institute-Australia's Future Tax and Transfer Policy Conference</u> held in June 2009 as part of the Henry Review of Australia's Future Tax System, and he participated in the <u>Tax Forum</u> held in Canberra in October 2011.

In 2018 he was elected as a <u>Fellow of the Academy of Social Sciences in Australia</u>. In 2022, he was appointed as a Member of the Australian Government's Interim Economic Inclusion Advisory Committee (<u>EIAC</u>).
